## Application Checklist (2026-2027)

- ☐ Submit your application via the Taught Postgraduate Online Application System. The application links are accessible via this [link](#).
- ☐ Pay the application fee of HK\$600.
- ☐ Remind your referees to submit their forms of reference via the hyperlink provided in our email invitation with the subject “Request for Statement of Reference” before the upcoming application deadline. At least one of them must be an academic referee from the university that you have graduated or will graduate from. The academic referee(s) is required to provide an official profile or directory link from the university website when completing the form of reference. Form of reference without this profile or directory link will be considered incomplete, and your application will NOT be further processed.  
*\*Your referees will receive our email invitation through the official email accounts that you provided in the Referees section of your application.*
- ☐ Upload the following supporting documents to the **HKU Business School TPG Application Document Upload System** no later than **TWO working days** after the application deadline of the round you are applying to. If there are further updates to your submission, you need to upload a full set of the updated documents under that particular category and the new submission will then overwrite the previous submission.

  - Past contribution to society and/or wealth management industry development
  - How your career aspiration may contribute to society and/or wealth management industry development after graduation from the Master of FWM programme
  - Intended use of the scholarship money, if received

**You may be invited to record and upload admission videos as additional mandatory supporting documents.** Applications with missing supporting documents will be considered incomplete and will **NOT** be processed further.

In the application stage, the original copy of supporting documents is **NOT** required and candidates only need to upload the softcopy to the HKU Business School TPG Application Document Upload System. If you receive an admission offer from our programme, we will ask you to submit the original/ certified true copy of the documents.
